# **5 Easy Ways to Sabotage Your Workers Comp Case**

As highly experienced attorneys who specialize in workers' compensation cases, our team knows all too well just how difficult it can be from the perspective of an injured worker waiting to see their claim through. It's normal to experience feelings of anxiousness and impatience during this time, but sometimes those feelings can manifest into problematic behaviors that could sabotage your case entirely - even if you have a good case. Our team looked at the top 5 reasons why cases can seem to drag on or fail entirely.



- 1. **Skipping your hearings, depositions, or medical appointments:** It takes a lot of time and effort from several parties to facilitate these appointments, so it's especially important to make them a high priority. It simply isn't possible to collect evidence and document medical progress if you don't show up at the appointments necessary to collect said evidence.
- 2. Calling your attorney too often & leaving long voicemails: Litigation takes a great deal of time and effort, and each case deserves your attorney's full effort but frequently disrupting their workflow can impede their progress and your case's success. Leave an effective message by simply and clearly stating your name, phone number, and a short summary of what you're calling about regarding your case. Any other details are more appropriate for direct conversations with your attorney.
- 3. Communicating vaguely, forgetting entirely, & lying: While you're not expected to recall each moment perfectly, it helps to be clear and concise. Be sure to work with your attorney to illustrate your point and document them effectively to recall later. Though this should come as no surprise, lying about your experience, or greatly exaggerating details can spell trouble for your case's chance of winning. Your attorney needs and values your honesty and will help ensure that your story remains credible.
- 4. **Pressuring, harassing, or threatening your attorney:** Calling your attorney repeatedly after office hours, taking an aggressive tone when speaking with them, threatening, or blackmailing your attorney are guaranteed ways to lose their interest. An attorney can and will petition the Workers Compensation Appeals Board (WCAB) to leave your case.
- 5. Comparing your case to others & refusing to compromise: It's entirely normal to read through and research cases that may be like your own, but keep in mind that each case is unique based on individual experience and circumstance. No two cases are the same and your experienced attorney can be trusted to make sure your case is going in the direction that's right for you. Help them by understanding this fact and doing your part to compromise for the benefit of your case.



- 1. The State of California holds the record for the most populated state across the U.S. Nearly 40 million people live in California, and more than half of those people live in Southern California!
- 2. California is approximately 1,040 miles long, 560 miles wide, and is the third-largest state in the U.S. behind Texas and Alaska. Within those measurements lies the largest county in the U.S. as well - Los Angeles!

### **Recipe of the Month**

### Three Bean and Beef Chili

This comforting, heart-healthy chili is perfect for cold February days. Use ground turkey or chicken for an even leaner option.

#### Ingredients

- 1 tablespoon olive oil
- 1 onion, diced (1 cup)
- 1 red bell pepper, diced (1 cup)
- 2 carrots, diced (1/2 cup)
- 2 teaspoons ground cumin
- 1 pound extra-lean ground beef (90 percent lean)
- One 28-ounce can crushed tomatoes
- 2 cups water
- · 1 chipotle chile in adobo sauce, seeded and minced
- 2 teaspoons adobo sauce from the can of chipotles
- 1/2 teaspoon dried oregano
- Salt and freshly ground black pepper
- · One 15.5-ounce can black beans, drained and rinsed
- One 15.5-ounce can kidney beans, drained and rinsed
- One 15.5-ounce can pinto beans, drained and rinsed



#### **Directions**

- 1. Heat the oil in large pot or Dutch oven over moderate heat. Add the onion, bell pepper and carrots, cover and cook, stirring occasionally until the vegetables are soft, about 10 minutes. Add the cumin and cook, stirring, for 1 minute.
- 2. Add the ground beef; raise the heat to high and cook, breaking up the meat with a spoon, until the meat is no longer pink.
- 3. Stir in the tomatoes, water, chipotle and adobo sauce, oregano and salt and pepper. Simmer, partially covered, stirring from time to time, for 30 minutes.
- 4. Stir in the beans and cook, partially covered, 20 minutes longer. Season, to taste, with salt and pepper.
