# Is It Worth It to File a Social Security Disability Appeal?

If you have been denied disability benefits, know that you have the right to <u>appeal</u>. The appeal process is designed to redress denied claims. At this point, you may be asking yourself – should I appeal a denial of Social Security disability (SSDI) benefits? Is it worth the time and effort? The answer, in most cases, is an emphatic YES! These claims often get rejected because the information, records, and evidence presented are incomplete or not fully provided.



The social security disability appeal process has four levels.

- 1. Reconsideration: The first level is to request a reconsideration. A reconsideration is a complete review of your application by a Social Security Administration (SSA) claim examiner who was not a part of your initial decision. If you have new evidence regarding your medical condition and inability to work, you may submit it with your request for reconsideration. Typically, you have sixty days to file an appeal from the date you receive the letter from SSA. This level of the appeal process may be a good time to consider talking to a professional a Social Security disability attorney to review your case and give you an idea of your chances of winning an appeal.
- 2. Administrative Law Judge Hearing: If your application is unsuccessful again at reconsideration, you can take your appeal to the next level, requesting a hearing before an administrative law judge (ALJ). Generally, you have sixty days for filling this type of appeal from the date of the denial of your request for reconsideration.

The hearing provides applicants to make an in-person argument as to why they should be awarded disability benefits. The judge can ask questions about your impairment, past employment, and work limitations and may have medical and vocational experts present. However, once you've filed a disability benefits hearing, be prepared to wait. Because of the COVID-19 pandemic, the wait time for a disability hearing has risen to over 14 months.

- 3. **The Appeals Council:** If your application for benefits gets rejected at the ALJ hearing, you can take your case to an <u>Appeals Council</u> for review. The council can either review your claim, reach a decision or send the application back to the ALJ for a second hearing.
- 4. **Appeal to a Federal Court:** If you disagree with the Appeals council ruling, your last option is to file a lawsuit in a Federal District Court.

The COVID-19 pandemic has severely affected economies, supply chains, and business models. People with disabilities are at a significant disadvantage when it comes time to apply for benefits. The proper support can make a world of difference.



# Recipe of the Month Chicken, Brie, and Apple Panini

This chicken, brie, and apple panini sandwich, sweetened with a drizzle of honey, comes together in minutes and is perfect for a quick weeknight dinner.

### Ingredients

- 4 slices Ciabatta bread
- 2 Tbsp extra virgin olive oil
- · 2 cooked chicken breasts, sliced
- · 4 ounces brie cheese, sliced
- 1 apple, cored and thinly sliced
- 1 1/2 Tbsp good quality honey
- 1 cup frisee (or your favorite greens)





- 1. Heat panini press on high. Using a pastry brush, brush one side of each slice of bread with olive oil and lay out two slices of bread, oil side down.
- 2. Arrange chicken slices on the bread slices, top with brie, followed with apple slices.
- 3. Drizzle with honey, top with frisee, and top with remaining bread slices, oil side up.
- 4. Open the panini press and place each sandwich on the press and close the lid.
- 5. Grill sandwich for 3-5 minutes, or until golden brown and cheese is melted. Slice in half and enjoy!
